The Resurrection of the Lord - Easter Sunday

The solemnity of Easter celebrates the defining moment in salvation history: the resurrection of Christ. "Easter Sunday" (including the Easter Vigil) is the pinnacle of the liturgical year, sometimes referred to as "the queen of the royal liturgical family." In the first reading from the Acts of the Apostles, Peter delivers a speech to Cornelius, a Gentile and "God-fearing" centurion, and his entire household. Peter's speech is a summary of the early church's original kerygma (oral proclamation) about Jesus.

In the second reading from Paul's Letter to the Colossians, we learn that in the resurrection, Christ defeated death and is now "seated at the right hand of God." But this does not conclude God's work in Christ. For those with faith in the crucified and resurrected Messiah, our "life is hidden with Christ in God," waiting to "appear with him in glory" at the end of the age.

The Gospel reading for Easter is the opening scene of John's Resurrection narrative. This moment, the discovery of Jesus' corporeal resurrection from the dead, is an event long reflected upon by many in our Christian tradition. As John tells us, even the original disciples had difficulty pondering the meaning: "They did not yet understand the Scripture that he had to rise from the dead." Without faith, the resurrection of Jesus from the dead remains a moment in time incomprehensible to the human mind."

Act of Spiritual Communion: It has long been a Catholic understanding that when circumstances prevent one from receiving Holy Communion, it is possible to make an Act of Spiritual Communion, which is a source of grace. Spiritual Communion is an ardent desire to receive Jesus in the Most Holy Sacrament and lovingly embrace him at a time or in circumstances when one cannot receive Him in sacramental Communion. The most common reason for making an Act of Spiritual Communion is when a person cannot attend Mass. Acts of Spiritual Communion increase our desire to receive sacramental Communion and help us avoid the sins that would make us unable to receive Holy Communion worthily.

Prayer for Spiritual Communion: My Jesus, I believe that you are present in the Most Holy Sacrament. I love you above all things and I desire to receive you in my soul. Since I cannot at this moment receive you sacramentally, Come at least spiritually into my heart. I embrace you as if you were already there and unite myself wholly to you. Never permit me to be separated from you. Amen.

Prayers of Praise: In addition to praying for communion with the Lord, it is also important to take time to offer God our praise. This can be done by celebrating the Liturgy of the Hours or through a Celebration of the Word service, which can be celebrated at home.
